HCATMA sells spaces only, No table rental available. HCATMA is unable to guarantee overlaps in vendor items. We are not always aware of this prior to setup day. Inquires accepted and can advise what items (cosmetics, food products, crafts, etc.) vendors have paid & reserved space for the show. Booths are prohibited from selling bottled water, soda or any food item (nuts, popcorn, etc.) that can be eaten at the show – this falls under Food Vendor Registration with Board of Health Certificate. Alcohol is NOT PERMITTED on the Grounds. CHILDREN MUST HAVE PARENTAL GUIDANCE AT ALL TIMES. ALL FAIRGROUNDS BUILDINGS ARE NON-SMOKING. ANIMALS MUST REMAIN ON A LEASH AT ALL TIMES AND PLEASE CLEAN UP AFTER THEM.
